The [Children's Online Privacy Protection Act \(COPPA\)](#), effective April 21, 2000, applies to the online collection of personal information from children under 13. The new rules spell out what a Web site operator must include in a privacy policy, when and how to seek verifiable consent from a parent and what responsibilities an operator has to protect children's privacy and safety online. This document is the Privacy Policy statement for the Aquastorm Swim Club regarding COPPA rules as they apply to children's online privacy.

HOW THE OPERATOR(s) use the child member's personal information.

1. To maintain a current list of active swimmers who are members of the club.
2. To maintain a current list of the child's parent(s) or guardian(s) contact information for the purpose of sending meet information, meet results, merchandise forms, and application packets.
3. To maintain a current list of the child's parent(s) or guardian(s) contact information for assigning volunteer duties to those parents listed.
4. To provide a location for parents to share photographs taken of the children during swimming meets and special events related to the club. (Parents will approve or disapprove the photographs submitted prior to their uploading on the website.)
5. NO CHATROOMS available to the children on this site.

KINDS OF INFORMATION collected on the child members.

1. First and last name of child member.
2. Physical address of child member.
3. Child member's parent(s) or guardian(s) first and last name.
4. Child member's parent(s) or guardian(s) physical address, email address and phone number.

PARENTAL OR GUARDIAN APPROVAL criteria for using children's personal information.

1. The child's parent(s) or guardian(s) has the option to agree to the collection and use of the child's information without consenting to the disclosure of the information to third parties.
2. The operator(s) of this website may not require a child to disclose more information than is reasonably necessary to participate in an activity as a condition of participation.
3. The child's parent(s) or guardian(s) can review the child's personal information, ask to have it deleted and refuse to allow any further collection or use of the child's information. The notice also must state the procedures for the parent to follow.

THIRD PARTY COLLECTION of children's personal information.

1. Discretely presented photographs of the children may be collected to develop promotional materials. Photographs used for this purpose must be approved by the parent(s) or guardian(s) of the child member prior to producing the promotional material.
2. Photographs may be uploaded into the 'Pictures and Videos' page of the site to share with other parent members. Parent members have the right to remove any photographs from the 'Pictures and Videos' page taken of their children.
